Guest Speaker: Blake Olsen

Blake touched on a few topics but mostly spoke on Medavie Blue Cross.

He briefly discussed membership cards, advising that hard copy cards may only be available on request, and CNPA may soon only offer a virtual (printable) card.

He advised that Blue Cross Premiums will be increasing 5% due to an increase in high claims.

Certain medications are restricted including Ozempic and Humera

He reminded that Blue Cross offers a free yearly eye exam.

The main point of his talk was to advise people to re-examine their options, and he will be putting out a letter sometime in the next 2 months advising them of this. He suggested that option 3c is the best option for most.
