Pharma care effective February 01, 2023, has expand diabetes, heart failure blood clot drugs coverage, This will hopefully in the near future be negotiated with our extended health care thru Medavie Blue cross, to cover increased coverage of medications.

The Office of the Seniors Advocate is an independent office of the B.C. provincial government acting in the interest of seniors and their caregivers. Along with COSCO, they provide free workshops to senior's groups. Presently offing more then 40 workshops, for presentation by trained facilitators.

COSCO and Seniors Advocate are working together on volunteer national health care for seniors.

The BC Provincial government is providing free of charge covid-19 testing kits. Also, Vaccinations for booster are available.

Reminder to fill out Homeowner grant to be eligible for the property tax reduction.

Suggestion for the CNPA to going to Vancouver game farm. best in nice weather.

Apparently blue cross was over charging for prescriptions in BC by 5%. This has been corrected.

The Standard dispensary of prescription pills is a 90-day supply. However, our Medavie Blue Cross plan allows for 100-day supply.

B.C. pharmacies can submit a claim to Pharma Care for medication review services provided by pharmacists to eligible patients. A medication review is a patient-care service that seeks to enhance a patient's understanding of their medication regimen, identify, and resolve drug therapy problems, and improve health outcomes. The service is provided by a pharmacist through a one-on-one, in-person appointment during which the patient and pharmacist identify all medications that the patient is taking, discuss how the medications are best taken and where.



appropriate, create a medication management plan to address any drug therapy. problems. At the end of the appointment, the pharmacist provides the patient with one or more documents listing their medications. This policy standardizes how medication review services are delivered across B.C.
