Correspondence: Jonn read an email received from Blake Olson regarding the 2016 C.N.P.A Scholarship program. It states that within the next couple of months there will be the launch of a new website giving all necessary information on Scholarship applications. It also stated that the amount for the Scholarships will be increased to \$1500 per year and 5 Scholarships will be available for the Mountain Region (B.C. /Alta)

No other correspondence was received.

New Business: John reported on updating the Constitution, Rules & Regulations Fraser Valley council. All new information will be available on the Fraser Valley website.

A motion was put forward by Jim Smith to extend the Executive terms to 2 years from the present 1 year effective June 2016. Vic Locke amended the motion stating that the four Executive positions - Pres., V.P., Treas., Sec., - should be elected two at a time on opposing years. That way we will not have the possibility of 4 new executive members all at one time. Therefore, the motion was amended to read as follows:

This question was sent to National office. They are reviewing the matter and will advise.

Elsie Taylor & John McDonald have volunteered to do this. Jonn also informed them, if there were any questions regarding the Audit, to speak with Vic Locke as he has done the Audit in past years.

As this was a pizza luncheon meeting, the pizza arrived so a motion to adjourn the meeting was made by Sharole Hanlen and 2nd by Ross Gregory at approx 2 pm. Carried.
